

## **STORE & CENTRALISE DATA MANAGEMENT INFORMATION FOR CONTROL AND COMPLIANCE**

Clients can run reports to verify data coverage with the business and system owners. Views are provided on an application's subscriptions, contributions, upstream/downstream connections, internal/external pricing & reference dependencies...all assisting with external data audits.

### **Desk & User Profiles**

#### **Key Features:**

- 'Desk Profile' – Create tailored requirements listings and manage dependencies (Applications, Excel, Trading etc.) on a per desk basis
- 'User Profile' – Create tailored requirements listings and manage dependencies (Applications, Excel, Trading etc.) on an individual user basis
- Produce reports on user profiles that sit outside of their generic desk profile
- Produce reports on market data services and exchanges utilised by each desk, highlighting any services or exchanges belonging solely to individual users
- Export / import from and into Excel.

- ✓ Helps identify 'gaps' from existing services
- ✓ Provides a fast, effective means of verifying services versus user count for compliance purposes

### **Application Profiles**

- A dashboard provides a consolidated view; dependencies can be viewed at an aggregated business level and include links directly to the market data used.
- Enables Exchange data drill-down (by frequency, type etc.) and contains links to key Exchange information in 3di's *Profiler*.
- Ability to upload Exchange and vendor contracts, addendums and schematics

- Ability to view an application's subscriptions, contributions, upstream, downstream, internal / external pricing and reference dependencies
- Search, export and report functions enable fast retrieval of information for a range of internal uses.

- 3di's Excel Data Dependency Evaluator (EDDE) plug-in enables DCDM users to access market data users' external vendor links within spreadsheets. Available at a desk or user level.
- DCDM can automatically upload organisational and service information from inventories (including MDM, FITS, InfoMatch, FinOffice) ensuring information and manual entry is not duplicated.
- DCDM can integrate with any business application to automate the loading of watch-lists.
